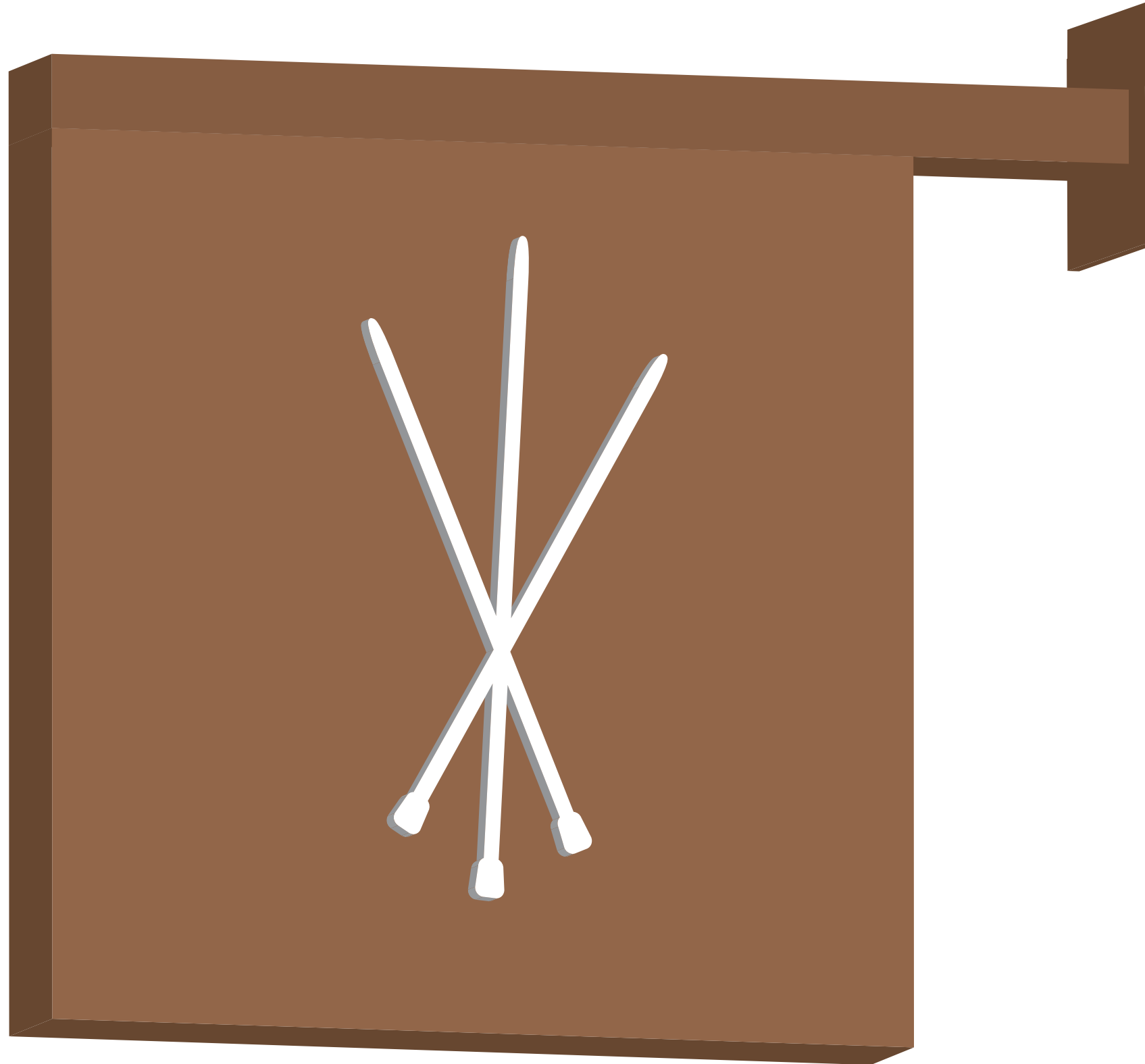


Blade Sign (double sided)

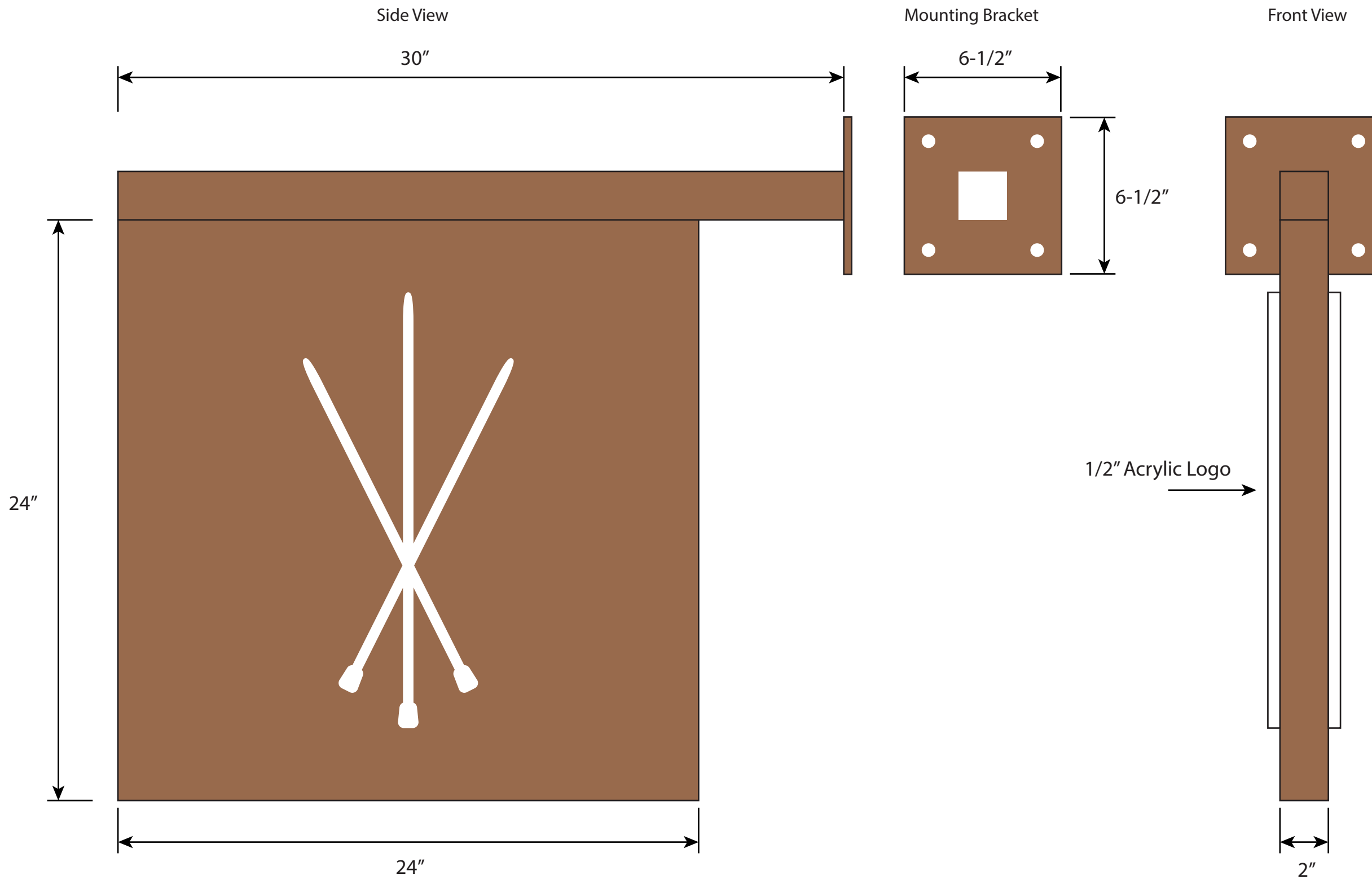
