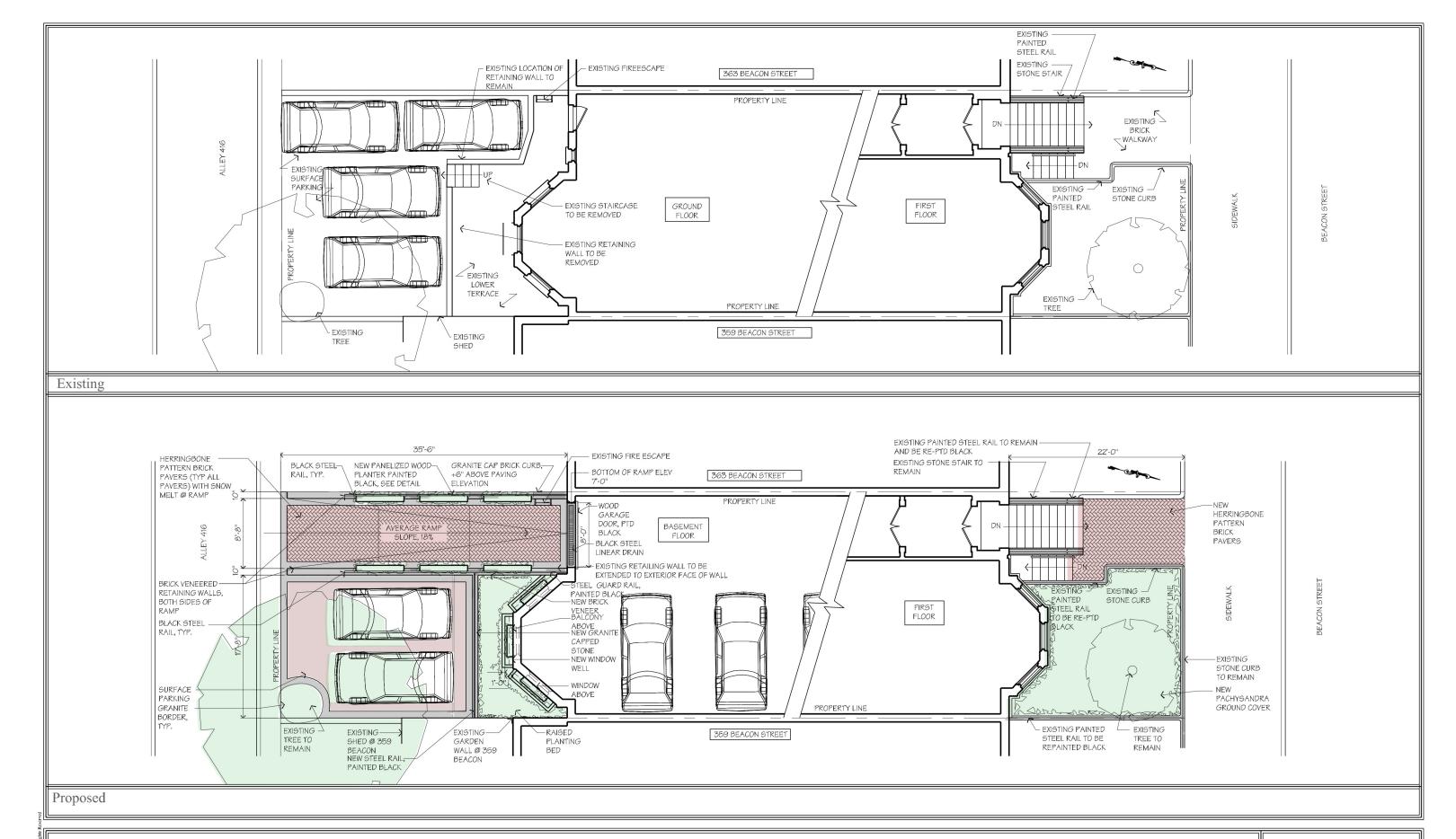

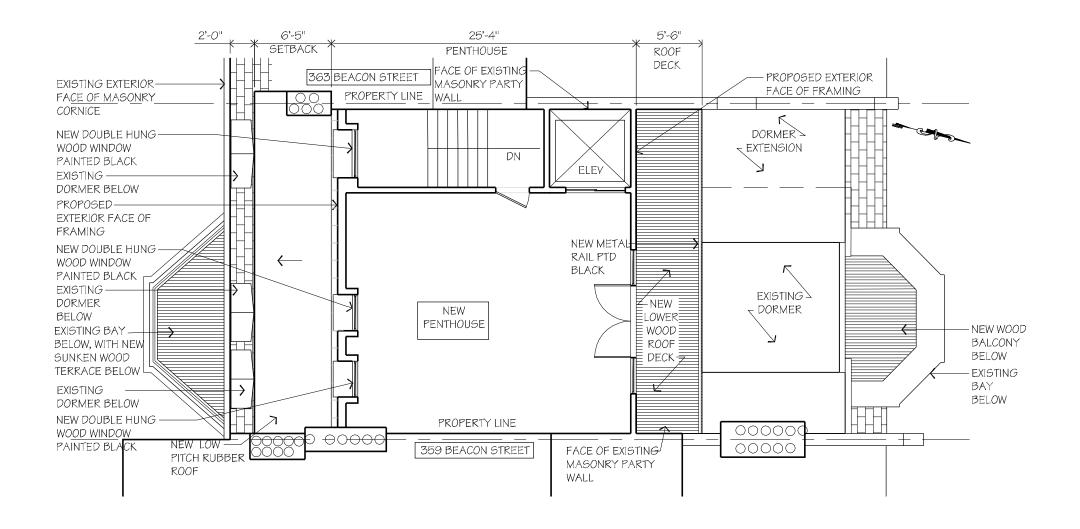

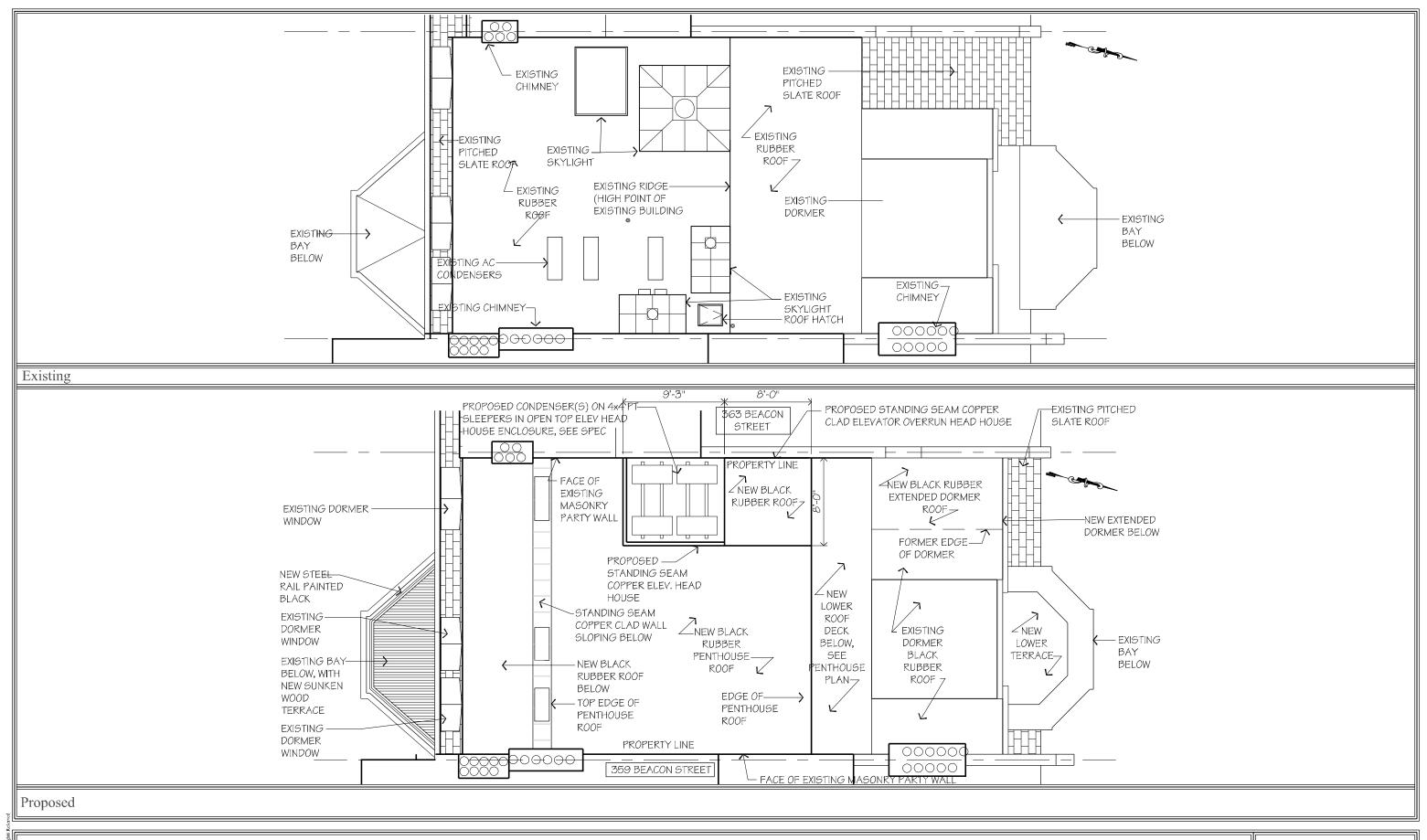

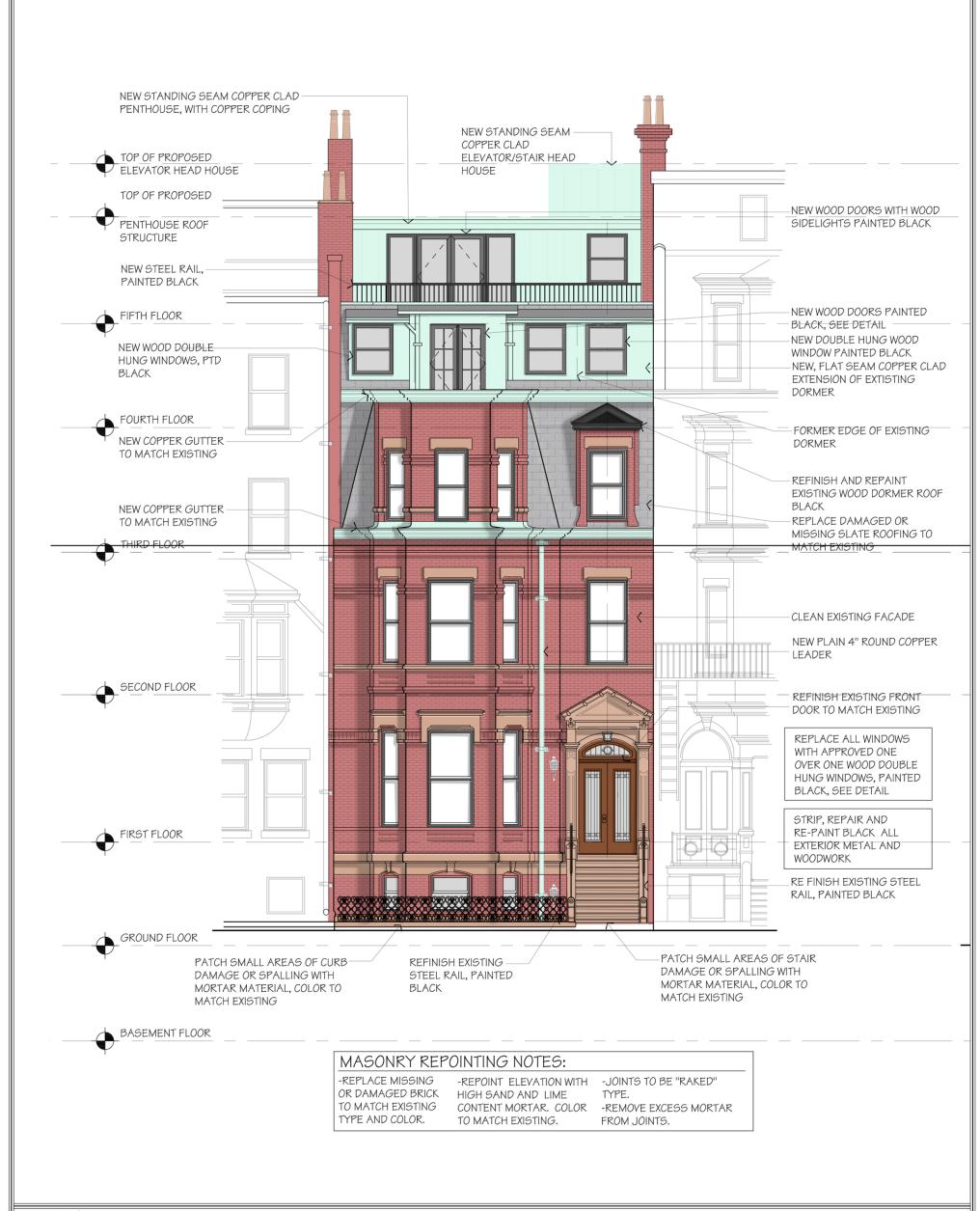

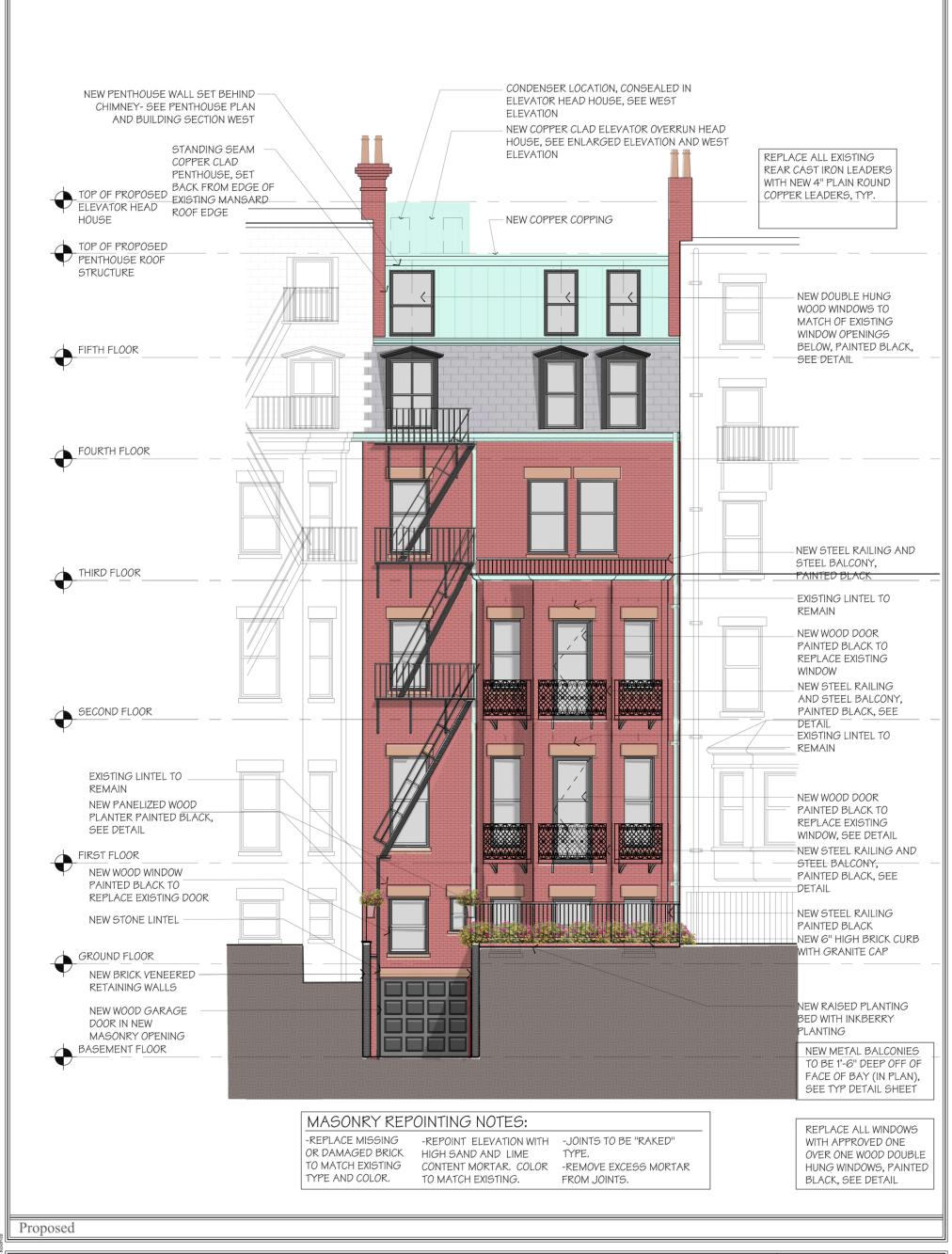

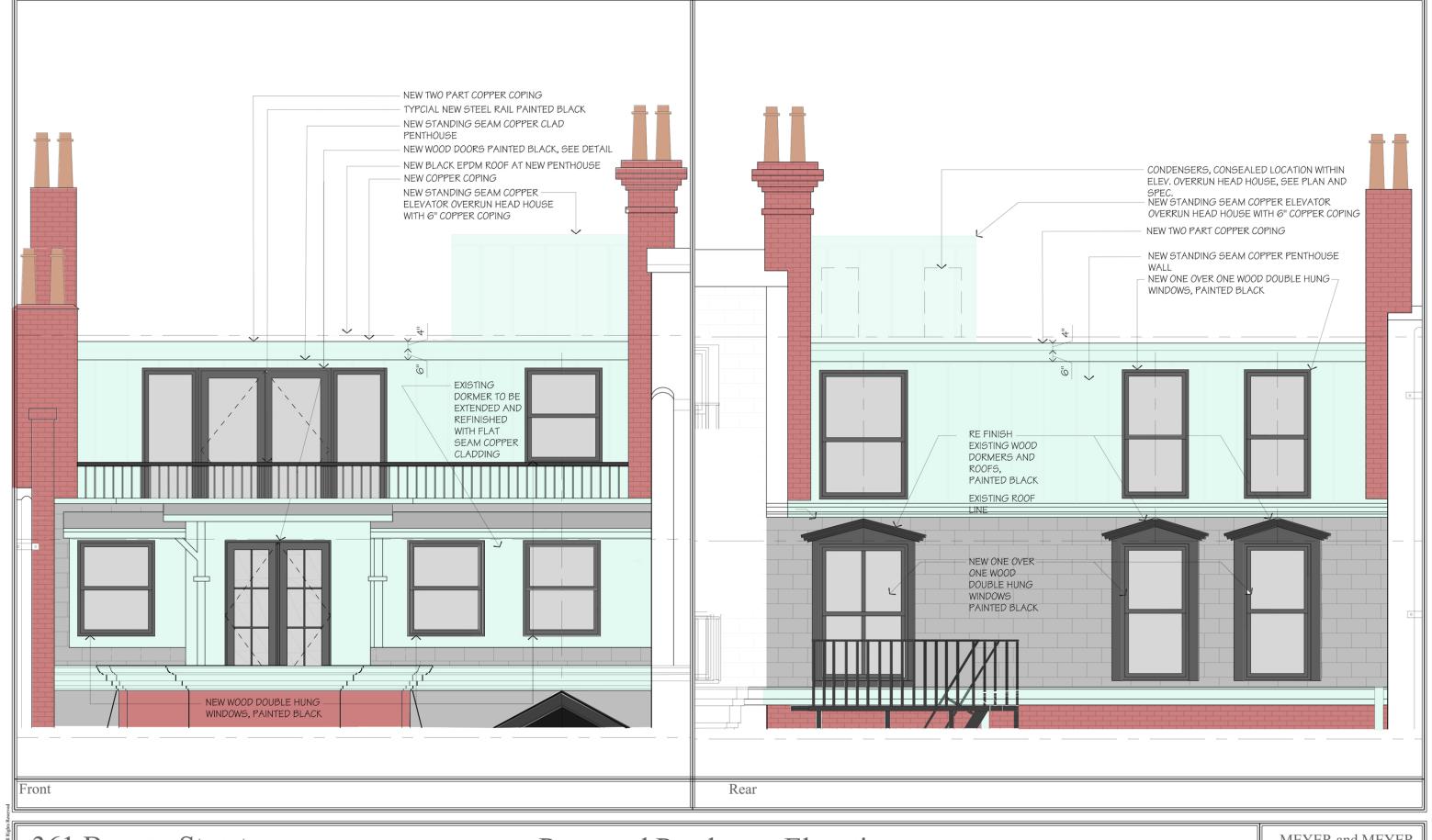
Proposed Rear Elevation

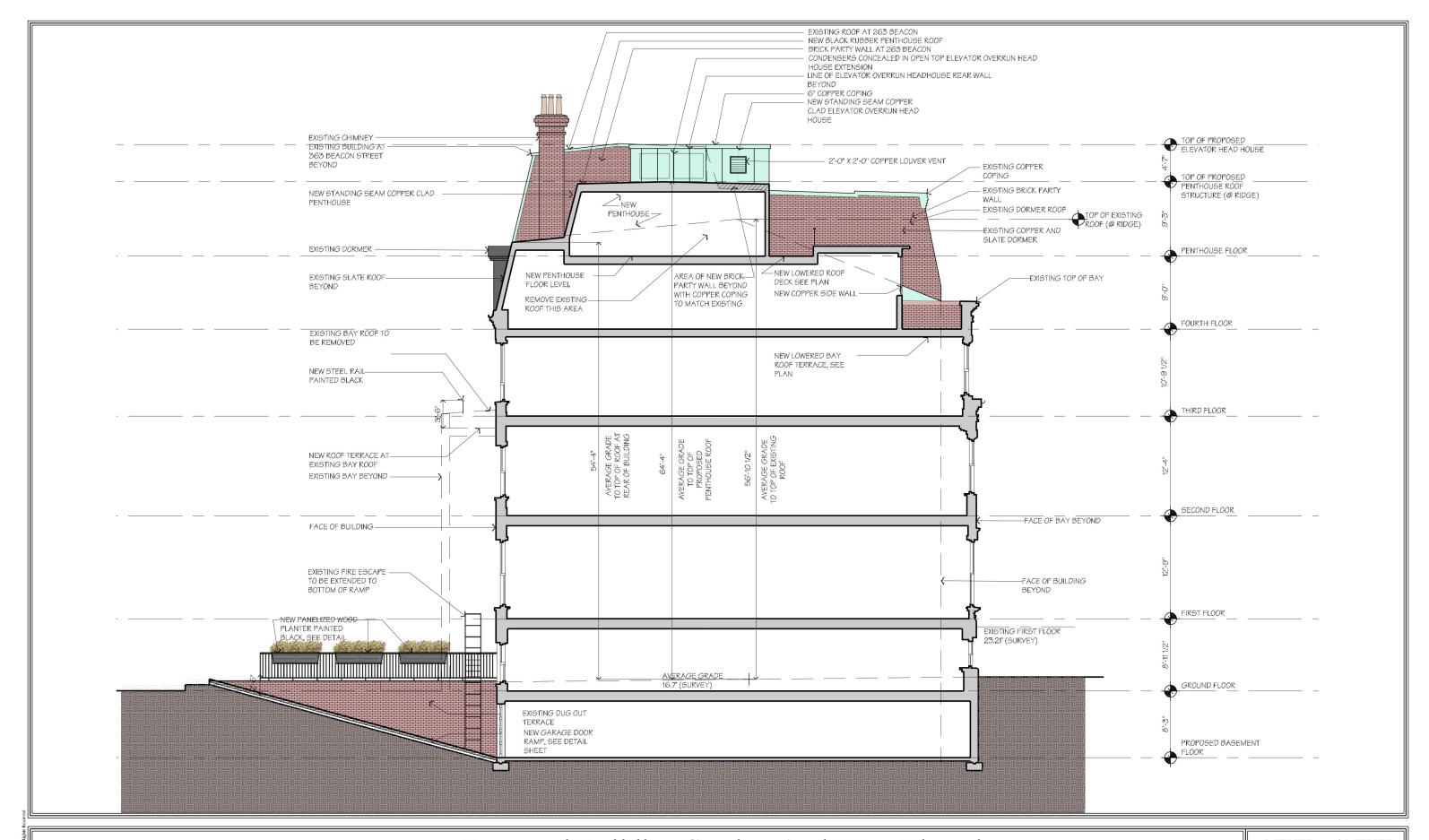
Proposed Penthouse Elevations

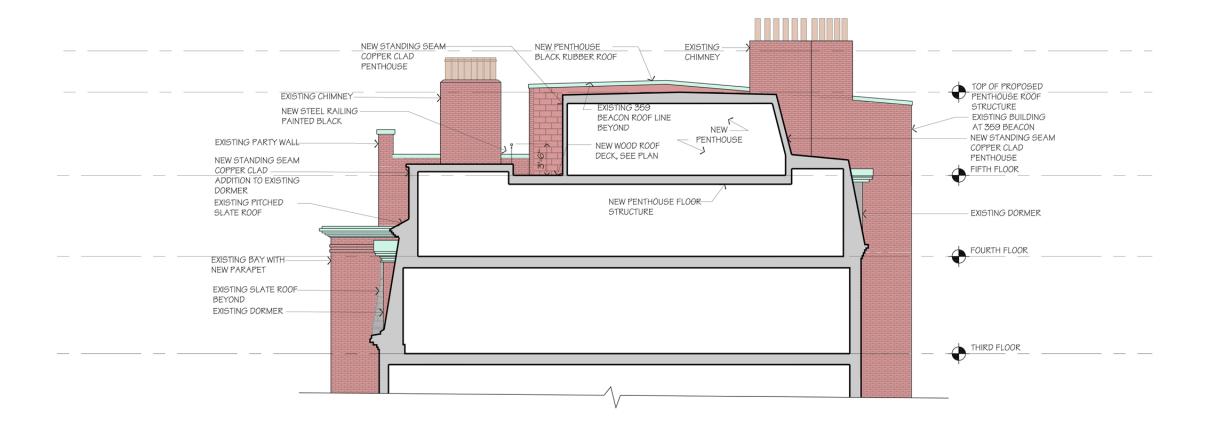
Proposed Building Section And West Elevation

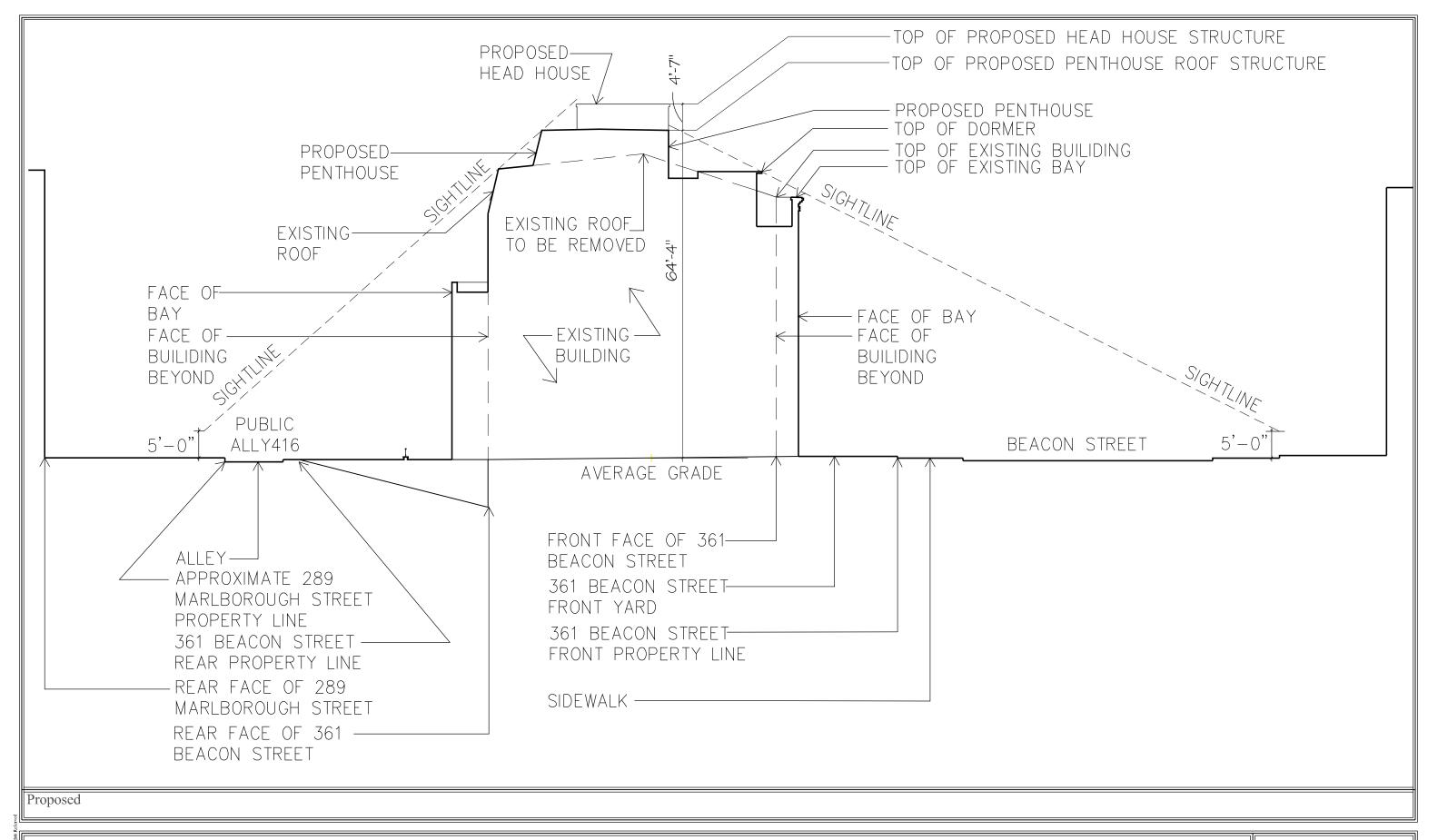
Proposed Building Section And East Elevation

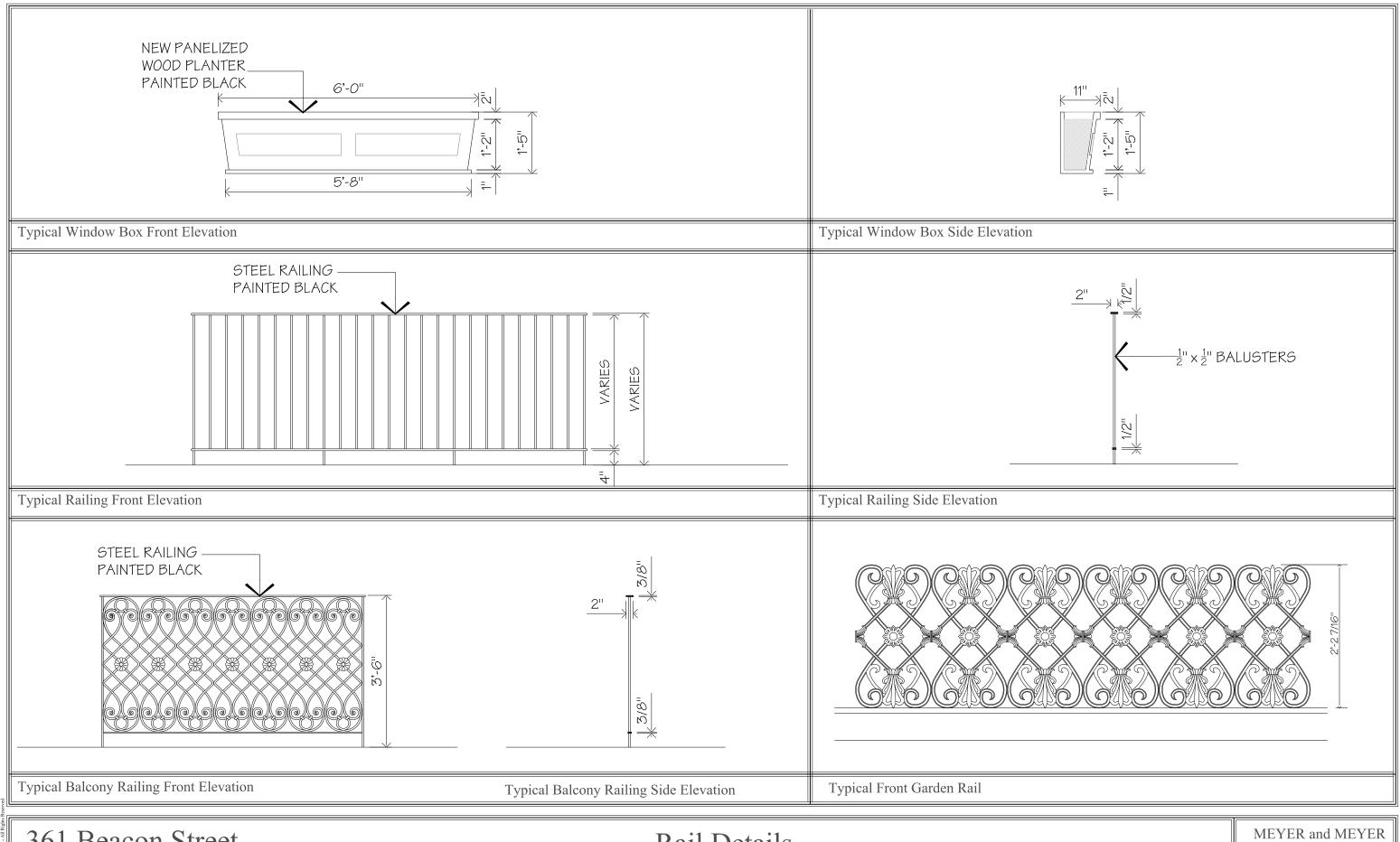
