
## 1. Welcoming Remarks

#### **BASELINE IMPROVEMENTS**

- Incorporate accessible internal pedestrian circulation network.
- Increase park visibility and provide external links to community.
- Preserve active recreational uses and add additional as feasible (i.e. tennis).
- Incorporate active/passive community gathering spaces.
- Upgrade lighting
- Enhance and define spatial use w/ trees



# ALTERNATIVES # 1-4



#### **PUBLIC COMMENTS**

- Alternate 1
  - o Too tight if all 3 fields are in use at the same time
- Alternate 2
  - o Consider adding an amphitheater to the community area
  - Western Ave. is a true boulevard bring the beauty of the park out to the street
  - o Wall is critical offers protection for the kids in the playground
  - Hockey near passive area can be disruptive
  - Balls from bike polo hit outside of the fence should not be near the street/passive area
- Alternate 3
  - Soccer too close to softball
  - Brighton High girls use multi-use fields
  - o Full size football / soccer, multi-sport field needed
- Alternate #4
  - Scheme is "Perfect". Provides 4 baseball/softball, separate multi-use field, 2 hockey courts, and basketball.




- Strong organization of ball fields

- Passive area at corner of Western Avenue & Park Road


### **Dislikes**

#### **PLAYGROUND OFFERINGS**

- 5<sup>th</sup> largest open space in Allston-Brighton.
- One of 6 city parks in AB that provides Little League and softball.
- Only 1 of 4 that provides field sports.
- Largest of playgrounds with similar offerings.
- In AB, accounts for:
  - ➤ 20% of multi-use fields
  - ➤ 33% of softball
  - ➤ 40% of little league
  - ➤ 50% of street hockey





#### **REFINEMENTS**

- Relocate courts to center of playground.
- Review existing trees and save as feasible.

## William F. Smith Recognition

- Dedicated on August 9<sup>th</sup> in honor of U.S. Marine Corps veteran William Francis Smith of Allston, who was killed in the line of duty in Soissons, France on July 20, 1918.
- Current playground lacks proper memorial.
- Manner of recognition to be determined.

### NAMING OF WILLIAM F. SMITH PLAYGROUND.

Coun. McLAUGHLIN offered an order that the Board of Park Commissioners be requested, through his Honor the Mayor, to have the playground now known as the North Brighton Playground, in memory of said Smith, who gave his life for the cause of freedom in the World War, and that said playground be suitably marked. Passed under a suspension of the rule.







### **Peace Pole**

A Peace Pole is a hand-crafted monument that displays the message and prayer *May Peace Prevail on Earth* on each of its four or six sides, usually in different languages. There are tens of thousands of Peace Poles in 180 countries all over the world dedicated as monuments to peace. They serve as constant reminders for us to visualize and pray for world peace.












## Baseball fields circulation -1813.5 ft. =0.34 mile Perimeter circulation -2890 ft. =0.55 miles
