The Boston City Council's Committee on Public Safety and Criminal Justice will hold a public hearing on Monday, December 5, 2016, at 1:30PM in the Iannella Chamber, 5<sup>th</sup> Floor, Boston City Hall.

The subject of the hearing is:

Message and order authorizing the Mayor's Office of Emergency Management to accept and expend a grant from the US Department of Homeland Security passed through the Massachusetts State Executive Office of Public Safety in the amount of Fourteen Million Two Hundred Sixteen Thousand Dollars (\$14,216,000.00) for the Urban Area Security Initiative FFY2016 grant to continue support of unique planning, exercises, training and operational needs, that will assist in building enhanced and sustainable security capacities to help prevent, respond to and recover from threats or acts of terrorism, including chemical, biological, radiological, nuclear and explosive (CBRNE) incidents.

This matter was sponsored by the Mayor and referred to the committee on November 2, 2016.
