TO THE CITY COUNCIL

Dear Councilors:

I transmit herewith a supplemental appropriation Order for various departments for FY18 in the amount of \$2,681,157.00 to cover the FY18 cost items contained within the collective bargaining agreements between the City of Boston and SENA. The terms of the contracts are October 1, 2016 through September 30, 2017 and October 1, 2017 through September 30, 2020. The major provisions of the contracts include base wage increases of 2% effective the first pay period of October of each fiscal year. The agreements also include other benefits including a new step beginning in January 2018.

As originally presented to you, the FY18 budget request included a Reserve for Collective Bargaining - a separate appropriation to fund projected collective bargaining increases. A separate Order has been filed to reduce that appropriation to support this supplemental request.

I respectfully request your support of this supplemental appropriation.
