## COMMITTEE HEARING NOTICE

September 3, 2017

The Boston City Council's Committee on Healthy Women, Families & Communities will hold a public hearing on Tuesday, December 12, 2017 at 3:00PM in the Iannella Chamber, 5th floor, Boston City Hall.

The subjects of the hearing are:

- Message and order authorizing the City of Boston to accept and expend the amount of One Million Two Hundred Fifty-Seven Thousand Eleven Dollars and Sixty Cents (\$1,257,011.60) in the form of a grant, FFY18 Title III-B: Supportive Services, awarded by the U.S. Department of Health and Human Services, pass through the MA Executive Office of Elder Affairs, to be administered by the Elderly Commission. The grant will fund a comprehensive and coordinated health and social service system, which assist elders to maintain independent living in their own communities as long as desired.
- Message and order authorizing the City of Boston to accept and expend a grant of Four Hundred Seventy-Four Thousand Two Hundred Thirty-Three Dollars and Seventy-Five cents. (\$474,233.75) for the FFY18 Title III-A Area Plan Administration, awarded by U.S. Department of Health and Human Services, passed through the MA Executive Office of Elder Affairs, to be administered by the Elderly Commission. The grant would fund administrative expenses of the Elderly Commission Area Agency on Aging.

These mattes were sponsored by the Mayor, and referred to the Committee on October 25, 2017.
