**AN ORDER AUTHORIZING THE CITY OF BOSTON TO ACCEPT AND EXPEND** the 2018 Senator Charles R. Shannon, Jr. Community Safety Initiative FUNDS, AWARDED BY MA Executive Office Of Public Safety & Security.

**WHEREAS**, the MA Executive Office Of Public Safety & Security, is being petitioned for the issuance of funds to the Police Department; and

**WHEREAS**, the funds in the amount of ONE MILLION SEVENTY-FIVE THOUSAND NINE HUNDRED FIFTEEN DOLLARS AND FORTY-ONE CENTS (**\$1,075,915.41**) would fund regional and multi-disciplinary approaches to combat gang violence through coordinated prevention and intervention, law enforcement, prosecution, and reintegration type programs.
