## COMMITTEE HEARING NOTICE

The Boston City Council's Committee on Ways and Means will hold a public hearing on Monday, May 14, 2018 at 12:30PM in the Iannella Chamber, 5th floor, Boston City Hall.

The subject of the hearing is:

0577 Message and order authorizing a limit for the Boston Centers for Youth and Families (BCYF) revolving fund for Fiscal Year 2019 to pay salaries and benefits of employees and to purchase supplies and equipment necessary to operate the City Hall Child Care. This revolving fund shall be credited with any and all receipts from tuition paid by parents or guardians for children enrolled at the center. Receipts and resulting expenditures from this fund shall not exceed Seven Hundred Fifty Thousand Dollars (\$750,000.00).

This matter was sponsored by the Mayor, and referred to the Committee on April 11, 2018.
