- 2. A portion of 2406 Washington Street, Roxbury, MA being Ward 12 Parcel 01263000 consisting of approximately 4,480 square feet of land adjacent to 135 Dudley Street but specifically excluding the portion of the Assessor's parcel retained for police use.
